VENDOR RELEASE & HOLD HARMLESS AGREEMENT

2b1 the Festival Coordinator does not participate in the construction or assembly of individual Vendor's exhibit. 2b1 provides space only on the October 25th event.

The Vendor hereby indemnifies and holds 2b1, its agents, associations, employees officers and servants harmless from any and all claims, including costs and attorney's fees resulting from, arising out of said Vendor's participation in this event. For the purposes of this agreement, the term "participation" shall include, but not be limited to, the delivery of equipment, merchandise, structures and product to their designated location, the set up and display of any such structure and arts or crafts, and the dismantling and removal of all such items from the area provided by or through 2b1 or its agents, associations, employees, officers and servants.

The Vendor hereby expressly assumes any and all risk of harm arising out of their participation and the participation of other artists in the Festival, including any risk resulting from the particular location of the space designated to them by the Festival Coordinator.

This agreement shall be effective immediately upon execution and shall continue in effect throughout the event period including set-up and tare-down.
